Clean Energy in Washington

In 2019, Washington's governor signed the **Clean Energy Transformation Act (CETA)** into law. This requires Washington utilities, including Avista, to meet new clean energy goals.

CETA Milestones

New requirements align with Avista's goals to offer a mix of renewable energy solutions to our Washington electric customers, such as wind, solar, hydropower, and biomass. Avista's current energy mix includes ~60% renewables and continues to climb.



Getting There

Avista's **Clean Energy Implementation Plan (CEIP)** is a four-year roadmap that shows how we will meet the energy and equity requirements set by Washington's clean energy legislation.

This plan includes **Customer Benefit Indicators (CBIs**) that measure how Avista is working to ensure all customers benefit from a clean energy future.

- Helping customers save with energy efficiency programs.
- Reducing greenhouse gas emissions.
- Ensuring a reliable clean electric system.
