Avista Solar Select Program (Schedule 87) Reservation Request

This Reservation Request is made and entered into by and between

("You" or "Your") and AVISTA

CORPORATION, a Washington corporation, ("Avista"), for service under Avista's Electric Tariff Schedule 87 (or "Solar Select Program").

Avista is developing a solar generation facility within its electric service area to serve commercial customers who would like to purchase solar energy. The Solar Select Program will be offered on a first come first served basis, and in order to manage the expected level of interest Avista is asking interested customers to sign this Reservation Request form. The expected start date for the Solar Select Program is January 1, 2019 (which will coincide with your January billing cycle), but is dependent on the actual construction of the project.

This Reservation Request does not legally commit you to purchase anything from Avista, but is requested to document your interest and to explain the terms of the Solar Select Program, which will be set out in a formal agreement.

The following sections describe the general terms of the Solar Select Program (note that all terms and conditions will be set forth in the formal agreement):

- 1. In order to participate, you must be a current Schedule 21, 25 or 31 electric customer with service in Washington. You must also satisfy credit requirements set forth by Avista.
- 2. If you elect to participate in the Solar Select Program, the following will apply:
 - You will enter into a Solar Select Program Service Agreement detailing all terms of and conditions of your participation in the Solar Select Program.
 - Avista will provide, and you agree to purchase from Avista, solar energy at a contracted volume up to 100% of the load of a meter located at your service location as listed on Page 3 of this Reservation Request. The energy will be allocated from the solar energy resource consistent with the contracted rates in Schedule 87.
 - As Schedule 87 states, the solar energy will be delivered to the Avista balancing authority area. You will remain a fully bundled customer and receive utility system power, however, your load will not be met in real-time exclusively by the solar energy resource but will be served through Avista-owned resources and contracts.
 - Avista will acquire the Renewable Energy Credits (RECs) that are created from the Solar Resource electricity production and Avista will retire them on your behalf in the Western Renewable Generation Information System (WREGIS) unless other terms are agreed upon between you and Avista.
 - You will be expected to make a commitment to the Solar Select Program of 8 years and there will be a fee for early termination. However, you can transfer your obligation from one location to another or you may also assign your Solar

- Select Program Service Agreement to another eligible customer and not be subject to the early termination fee.
- You will continue to pay the costs applicable to your existing tariff schedule (whether schedule 21, 25 or 31) and under Schedule 87 you will also pay a Solar Resource Charge of \$0.05268 per kWh for the duration of your Service Agreement.
- You will receive a credit for the energy-related power costs (Solar Resource Credit) applicable to your existing tariff schedule, \$0.02982 per kWh for Schedule 21, \$0.02707 per kWh for Schedule 25, and \$0.02664 per kWh for Schedule 31.
- You will also receive an incentive under RCW 82.16 for the energy you purchase under this Agreement (Renewable Generation Incentive). The Renewable Generation Incentive will be equal to the difference of the Solar Resource Charge minus the Solar Resource Credit, resulting in a net increase of \$0.00 per kWh for all energy purchased from the Solar Resource.
- Your monthly bill will show three new line items: (i) a credit for the Solar Resource Credit, (ii) a line item for the cost of solar energy (Solar Resource Charge), and (iii) a credit for your Renewable Generation Incentive.
