Program Eligibility and Guidelines

The following rebates are available for the ENERGY STAR/ECO-Rated Homes Program. Please see descriptions for complete rebate requirements. All programs are subject to change. **Request for rebate must be submitted within 90 days of home occupancy.** Offers apply to new construction homes and may not be combined with any other Avista rebate within a 12 month period of home occupancy.

Manufactured Homes

A **\$800 rebate** is available for new construction homes using Avista electric or Avista electric and natural gas that meet the ENERGY STAR/ECO-Rated Homes criteria and are verified as an ENERGY STAR/ECO-Rated Home. Homes must use Avista electric or natural gas to heat their homes and their hot water.

Stick Built Homes

A **\$1,000 rebate** is available for new construction homes using Avista electric or Avista electric and natural gas that meet the ENERGY STAR Homes criteria and are verified as an ENERGY STAR Home. Homes must use Avista electric or natural gas to heat their homes and their hot water.

* Note: Homes that use Avista natural gas to heat their homes and hot water, but receive their electricity from another provider, are eligible for a \$650 rebate. Homes in Idaho do not qualify for this offering.

Additional Conditions

- 1. Request for rebates must be submitted within 90 days of home occupancy.**
- The rebates listed are applicable to **new construction** of single and multifamily residences (up to a fourplex), including manufactured and modular homes.
- Rebates are not available for seasonal or recreational homes; homes must be a primary living residence.
- Only new homes qualify.
- Primary fuel used for space and/or water heating must be Avista electric or natural gas service to qualify.
- This rebate may not be combined with any other Avista rebate available within a 12 month period of home occupancy.
- Homeowners are responsible for complying with all applicable codes and regulations.
- Avista reserves the right to inspect energy efficiency measures prior to payment and will coordinate inspection as applicable.
- Avista may upon reasonable notice access customer's Premises to verify the installation is in compliance with this Agreement.
- Allow 6 to 8 weeks for processing and payment of rebate.
- A copy of ENERGY STAR®/ECO-Rated Homes certificate must be submitted for ENERGY STAR/ECO-Rated Homes rebate.

ENTIRE AGREEMENT/APPLICABILITY/ASSIGNMENT. This Agreement contains the entire agreement between Avista and the Participant and may not be modified except by a written instrument signed by both parties. Furthermore, this Agreement will be binding upon the successors and assigns of such parties. Participants may not assign this Agreement without prior written consent of Avista, which consent will not be unreasonably withheld. Avista may assign their agreement at its sole option.

ATTORNEYS' FEES. If any action is brought to enforce this Agreement, the prevailing party in such action will be entitled, in addition to any other relief, to an award of reasonable attorneys' fees and costs incurred in such action.
